INTRODUCTION

Tarpley Early Taylor was of the seventh generation of his Taylor line in America, the ninth generation of the Tarpley line, and the fifth generation of the Early line. Of his ancestors. William Tarpley is the first of which we have found record. He bought land in York County, Virginia, in 1635. His son John had two sons, John and James Tarpley, who were in North Farnham, Virginia, in 1690. So far as we know, our first Taylor ancestor in America was Richard Taylor of North Farnham, Virginia. The earliest record of Richard Taylor, found in the courthouse at Tappahannock, Virginia is dated 1664. These two families were united about 1740 when George Taylor, third generation of our Taylor line in America, married Mary Tarpley, fifth generation of the Tarpley line in America. We have no record showing from what part of Britain these Tarpley and Taylor ancestors came.

Three generations of Taylors lived and died in North Farnham Parish, but the fourth generation moved westward, first to the Winchester area in the Shenandoah Valley of Virginia, and then on to the South Branch of the Potomac in Hampshire County, West Virginia. Toward the end of the eighteenth century the first Tarpley Taylor's children moved to Kentucky and settled in that part of Mason County which later became Fleming County. William E. Taylor was born in 1806 in Fleming County, went as a young man to Pike County, Missouri, thence to Illinois where Tarpley Early Taylor was born in 1837, and then moved to Iowa in 1839.

Our first ancestor of the Early line in America was William Early. We do not know when he arrived in America, but his son Thomas was born in 1742 in Union County, New Jersey. William Early had come from Ulster, Ireland, by way of Chester, England, where he married Mary Marlyn. Thomas Early married Euphemia Carr of Scottish descent, and settled in Hampshire County, West Virginia, near where

the Taylors lived and later moved to Mason County, Kentucky, as did the Taylors. Tarpley Early Taylor's grandfather, George Taylor, son of the first Tarpley Taylor, married Mary Early, daughter of Thomas Early, and thus brought the Early name into the Taylor family.

Our first Taylor ancestor in America, Richard Taylor, had two sons, one named Richard, the other Simon. Simon Taylor is a name that recurs in the family for many generations. According to T. H. Warner, a genealogist at Tappahannock, Virginia, a Simon Taylor was brought to Virginia as an indented servant about 1650 by Moore Fontleroy. Mr. Warner suggested that Richard may have been a younger brother of Simon and his use of the name Simon for one of his sons is an indication that this may be true. On page 55 of vol. D - 3 of the record in the courthouse at Tappahannock, Virginia, is the following statement: "July 9, 1664. Richard Taylor received from Rappahannock County Court in settlement of amount due from estate of Col. Moore Fontleroy the sum of eight hundred pounds of tobacco due him for servant's wages as per order of court."

There is evidence in the Court Records that the first Richard Taylor had some education, since he signed his name to certain documents, but such education as he had was doubtless acquired before coming to America. For the next three generations, the husbands and wives who were our direct ancestors made their cross mark on deeds and wills, indicating that they had had no educational opportunity. Such opportunities were exceedingly scarce. There were then no public schools in Virginia.

One member of a family often had all the schooling benefits. In the Tarpley family, for instance, John received some education but James did not. Simon Taylor's grandson Simon, son of John, received some education, became a contractor, and built the first jail erected in Winchester, Virginia. He also was the builder of the John Hite house a few miles

south of Winchester on Route 11. In 1782 he took the census in his area in Hampshire County, West Virginia, and again in 1784.

On the other hand, Simon's first cousin Tarpley Taylor apparently had no education. However, in his will which was probated when the oldest of his five children was only thirteen years of age, Tarpley Taylor showed his interest in education by requesting that his estate be used for the education of his children. He asked that they be taught to cipher and write, and to read in order that they might read the Bible. (Two Bibles are mentioned in the list of his property in the court records at Romney, West Virginia.) His desire in this respect was carried out. All of his children did learn to cipher, read, and write. His son John Taylor was for a time a member of the State Legislature of Kentucky. And the records of Fleming County, Ky., show that George Taylor was a citizen of considerable prominence in benevolent activities, particularly in connection with orphan children.

There is evidence that the Tarpleys and the Taylors were interested in religious matters. They were connected with the church at North Farnham, Virginia. The church building now standing in North Farnham was built from 1734 to 1737. The records kept by the rector of that church provided the birth dates of some of our ancestors, particularly the first Tarpley Taylor, and indicates that his parents were George and Mary Taylor. This church building was damaged during the Civil War. When the building was restored in the 1920's, a bronze tablet, as a monument to our ancestors, was placed on the end of the front pew on the right side of the central aisle as the rector views the andience

Another evidence of the family interest in religious activities is found in the bell that was given to the Bruton Parish Church in Williamsburg by James Tarpley in 1761. James was at that time a merchant in Williamsburg, having moved there from North Farnham. That sweet-toned bell has been

in use for nearly two centuries. Bruton Church is but a short distance from the gate of William and Mary College, and the bell has doubtless been a cultural influence in that institution as well as in Williamsburg.

William E. Taylor, who settled in Iowa in 1839, took special interest in both the building of a school and a church in his neighborhood; they became known as the Taylor School and the Taylor Church. His son Tarpley Early Taylor was much interested in church work and foreign missions and took the lead in building a church in Stockport after the railroad came through and Stockport became a market center for the area. A later member of the Tarpley Early Taylor family, inspired by the influence of the Tarpley bell in the Bruton Parish Church, Williamsburg, Virginia, presented to Drake University and the University Church of Christ the thirty-bell Deagan type carillon, installed in 1939, which serves both the campus and the church. The record as presented in the following genealogy shows that an interest in education has continued through the years.

The generations are indicated by Roman numerals, beginning with Richard Taylor I, etc. Information regarding wives or husbands of direct descendants is enclosed in parentheses.
